#### Treasurer's Report: Amanda

#### **Old Business**

- 1. Leap and Compete February 17, 2024
  - a. 87 skaters registered.
  - b. Went very well, no major issues thank you Heather for organizing a great event!
  - Need to work on better volunteer sign-up for next year.
    The Volunteer Committee has already has already worked on a plan for getting volunteers.
  - d. Need to better inform skaters/parents of changing room and ready room details.

The ready room concerns have been addressed by Shannon the Skate Safe coordinator and Erica.

- 2. April Ice contract signed, and ice paid for
  - a. Skating will be on Sunday and Tuesday evenings and Friday mornings.

- i. Tuesdays: 6-8 pm
- ii. Fridays: 6-8 am
- iii. Sundays: Either 5-7 pm or 6-8 pm
- b. Private ice only
- c. Will have a list of coaches available to coach that month and Kayla will work on schedule.
- d. Spring hockey session.
  - i. Proposed Learn to Skate USA Hockey for 1 hour every Tuesday costing \$40 for a 4-week session. Megan would coach with Heather or Kayla helping to coach if have more than 9 sign-ups. Megan would be paid the \$40 private lesson rate rather than the regular rate.
  - ii. If 5 or fewer sign-ups the rink will cover ice cost, otherwise will negotiate a cost. This is in addition to already scheduled ice time.

Motion made to approve Learn to Skate USA Hockey class at \$40 for the class and paying Megan private lesson rate by Shannon, 2<sup>nd</sup> by Andy. Motion passed.

Motion amended to make cost \$50 rather than \$40 by Shannon,  $2^{nd}$  by Andy. Motion passed.

  - a. Coach availability will be confirmed in the coming months, unable to confirm until other important competition dates are set.

- 4. Skate Sharpener Andy any updates?
  - a. Andy & Ginger have decided to buy a skate sharpener on their own to relieve the club of it. It will be separate from the club. Hope to start after the 2024 Prom. Thank you for taking that on. You are much appreciated.
